Application for Participation

Tarheel Canine Protection Sports Association is an association of members who train with the common goal of entering competitive obedience and controlled aggression trials, such as PSA, Mondio Ring, Schutzhund and other recognized dog sports. Training is conducted under the direction of the trainers at Tarheel Canine Training Inc. of Sanford, NC.

Rules for Participation

1. Application and Waiver must be filled out and signed prior to being reviewed for acceptance.
2. Tarheel Canine Training inc. is the sole authority regarding participation in the training association, and reserves the right, at any time, to terminate the training privileges of any accepted member without prior notice.
3. Tarheel Canine Training Inc. reserves the right to set special association membership rates at its sole discretion, and to set and change training meeting times without notice.
4. Tarheel Canine Training Inc. reserves the right to charge training fees in addition to regular dues for the association.
5. Dues shall be \$_____ per year, payable quarterly.
6. Rules of conduct
 - a. No alcohol or illegal narcotics are allowed at any time on the premises of Tarheel Canine Training Inc., nor shall any person participating in training be under the influence of illegal narcotics or alcohol. Immediate termination of membership shall result.
 - b. The training director, or a representative of Tarheel canine Training Inc. (only a certified trainer) shall be present for the association to meet and conduct training on the premises of Tarheel Canine Training Inc.
 - c. No guests may be brought to any training session without prior approval.
 - d. No video or audio taping is allowed without prior approval.
 - e. All dogs brought to training must be secured in a crate in the vehicle of the owner.
 - f. Members are required to keep current vaccinations for Rabies DHLAPP and Bordatella.
 - g. All dogs must come to and from the field on leash.
 - h. The trainers of Tarheel Canine Training Inc. may at any time dismiss a member from a training session, with or without cause.
 - i. All association members are required to fully participate in the life of the association, including participating in trials, assisting in the training of other members' dogs, assist in the production of hosted trials, seminars, and matches for which other fees may apply.
